# Barcelona is the only city in the world with nine buildings on the UNESCO World Heritage List, evidence of its cultural wealth





Since it was founded over two thousand years ago, it has been the traditional gateway to Spain, through which a multitude of cultures have entered to enrich the city. You can follow the traces of this history and diversity as you walk through the city: through the Barrio Gótico, built over the Roman ruins; and through the Eixample district, with its "Catalan art-nouveau" or Modernista buildings, which is a showcase for Gaudi's dazzling architecture, being laid out on an ordered and rational grid pattern.

It is more than 20 years now since the 1992 Olympic Games: the occasion for a deep transformation of the city's seafront area, and a milestone in Barcelona's overall process of renewal, which has continued into the 21st century and is still going on, showing the city's dynamic and pioneering spirit. The result is a destination that combines an impressive event-friendly infrastructure with a buzzing street life.

It is also worth mentioning that gastronomy is one of the mainstays of Catalan culture: the region's most famous chefs have made Barcelona synonymous with an extraordinary, varied and high quality culinary cuisine.

CLIMATE: Barcelona has a mild Mediterranean climate, quite humid but not much rain. The average temperature in November is 57°F/14°C (min. 52°F/11°C max. 66°F/19°C).

### SCHEDULE OF EVENTS

The 15th Open Forum programme will begin on Wednesday, November 5 with an optional new member/ first time attendee reception for new FICPI members, as well as any existing members who want to get more involved in the Federation's work.

The new member/first time attendee reception will be followed by a welcome reception with a special programme of entertainment at the *Palau de la Música Catalana*.

The Forum will continue with business meetings on Thursday and Friday. A plenary session will be followed by the usual "three streams" format, intermingled with special break-out workshops dealing with specialised topics in the fields of patents and trade marks.

The Museu Marítim de Barcelona will be the venue of the Forum closing dinner on Friday, November 7.

Delegates' Guests' (DGs) tours are included on Thursday and Friday.

For the afternoon of Wednesday, November 5, optional tours have been organised. On Saturday, November 8, optional excursions are also scheduled.

# **LANGUAGES**

All working sessions are held in English.

Catalan and Spanish are the official languages; English is fairly widely spoken.

For the tours, the organisers hope to be able to provide French and German speaking guides as well as English. Please indicate your preference on the booking form.

Please note that French and German speaking guides will be provided only if there are sufficient numbers of persons requesting them.

# **VENUE & ACCOMMODATION**

The Hotel Rey Juan Carlos I is the conference hotel while the meeting spaces for the 15th Open Forum are located in the adjacent Palau de Congressos de Catalunya.

Situated in a privileged location, the hotel dominates the Avenida Diagonal in Barcelona, the city's main street: a location with good access that connects easily to the airport (12 km away) and to the historic city centre.

Opened on occasion of the 1992 Olympic Games, the *Rey Juan Carlos I* has since enlarged its facilities with the addition of the wellness and spa club, thus becoming a real "urban resort".

The Palau de Congressos de Catalunya, a symbol of contemporary Barcelona, is located steps away from the hotel, with an exclusive entrance through its beautiful gardens designed at the beginning of the 20th century by the great Catalan landscape gardener Fontserec.

The hotel offers a choice of accommodation between Standard and Executive rooms; the Executive rooms are all located on the 12th floor and grant free access to the exclusive Executive lounge.

# AIR TRAVEL PARTNER

### **AIRPORT**

Barcelona has excellent transport links with the rest of Spain and Europe, with domestic and international airlines operating almost 900 daily flights to more than 150 destinations throughout the world.

The main airport, El Prat, is located 16 km south of the city and only 12 km from the Hotel Rey Juan Carlos I which can be reached by:

Taxi: 15 minutes drive.

Train/Metro: 40 minutes: take the train to Sants Estació station; from there, take the metro line n. 3 (green line) to Zona Universitaria (2 minutes walking distance from the hotel).

Bus/Metro: 40 minutes: aerobús shuttle bus service (A1, stopping right in front of the terminals) links the airport to the city centre. Get off the bus at Plaça Espanya (first stop), then take the metro line n. 3 (green line) to Zona Universitaria.

The airport is well connected with central Barcelona, by: aerobús (A1 and A2); train (RENFE); bus (TMB) and night bus (NITBUS).

Some low cost airlines use Girona airport instead, which is situated about 90 km from Barcelona and is connected to it by several buses.

### **TAXIS**

Barcelona has a fleet of about 10,500 taxis, which are recognisable by their yellow and black livery. Taxis can be found easily at the airports; there are several ranks throughout the city, and taxis may also be hailed in the streets.

Transportation for the DGs' tours and the optional excursions, as well as for the social events will be by bus, and will be available exclusively for those who make arrangements with our organisers at the hotel pre-booked for FICPI. Informal dinner (November 6): Casual clothing (no tie required).





Session 1	Increasingly IP offices are establishing modern approaches aimed at improving procedures for users through the adoption of enhanced electronic facilities and communications with each other. We have seen the Vancouver group of Canada, Australia and the UK partner with WIPO to develop Centralised Access to Search and Examination (CASE), a digital library of search and examination material. China, New Zealand and Singapore have since joined this initiative. Within the IP5 offices of the EPO, JPO, KIPO, SIPO and USPTO, we have seen the introduction of or plans for the Common Application Format, the Common Citation Document, the One Portal Dossier and now the Global Dossier, which will integrate the IP5 proposals with WIPO and CASE. It is said the Global Dossier will advance the patent system by reducing user costs through increased efficiencies, international examiner collaboration and enhanced work sharing. Architects of this initiative aspire to users accessing one portal to manage filings in all participating countries thereby avoiding costs, for example relating to duplicate documentation. Other cost and efficiency achieving harmonisation is planned by the Tegernsee Group of patent offices, and WIPO is proposing its ePCT system of simplified national phase filing. Panellists will expand on all of this and more, and will discuss its likely impact not only on the professional services we offer but also on our profession itself. Session 5	Patent litigation in Europe has been a national domain. Thus it is not harmonised, like the colours of our cars. However, although nothing prevents customers from buying cars of all colours, black or silver prevail. Similarly, patent litigation plaintiffs tend to pick the few mainstream fori. The UPC should harmonise patent litigation in Europe. One significant question is what colour will the litigation be, black and silver or pink and yellow? In late 2014, we are close to the start of the UPC. Top experts will provide the latest news and their views on the colours of litigation in the UPC. # Option A: Basilica of the Sagrada Familia

Meeting point: main lobby at 2:00 pm

The Sagrada Familia is one of the iconic symbols of Barcelona and one of the most famous churches in the world. This is partly because of its unique architecture, created by the genius Antoni Gaudí, and partly because its construction has mirrored the bygone age of great cathedrals, when it took two centuries to build a great Gothic church. Although still incomplete, the church is a UNESCO World Heritage Site, and in November 2010 was consecrated and proclaimed a basilica by Pope Benedict XVI.


Built between 1905 and 1908, at the height of the Modernista building boom in Barcelona, the Palau de la Música Catalana is, together with the Hospital de Sant Pau, the masterpiece of Lluis Domenech i Montaner, one of the key figures of Catalan modernism. It is a UNESCO World Heritage Site and Barcelona's most popular concert hall.

Forum delegates and their guests will have the opportunity to listen to a concert performance of sardanas (typical Catalan music) inside the spectacular concert hall. A cocktail reception will follow in the foyer.

# Thursday - November 6, 2014

# **Guided tour "Montserrat"**

Meeting point: main lobby at 9:30 am. By bus. Return 4:00 pm.



A mountain and a monastery, Montserrat is one of the most emblematic places in Catalonia, not only for its beautiful landscape, but also for its historical, political and religious significance throughout the region.

Perched 725 metres above the sea level, the monastery

is the site of a Holy Shrine dedicated to the Black Virgin of Montserrat, Patron Saint of Catalonia. Every day one can still hear songs sung by the oldest children's choir in Europe, the "Escolania de Montserrat". The Museum has an important selection of early paintings, spanning from the 13th to the 18th centuries, and the largest and most representative collection of Catalan paintings from the 19th and 20th centuries.

# Informal dinner - Restaurant "Can Cortada"

Meeting point: main lobby at 7:30 pm. Transfer by bus. Avda. de l'Estat de Catalunya, s/n - tel. +34 93 4272315

Forum delegates and guests will spend a relaxing evening enjoying a traditional Catalan dinner in the rustic atmosphere of the *Can Cortada* restaurant. The beginnings of the current farmhouse go back to the XI century, when the gentlemen of Horta (a neighbourhood of Barcelona now completely swallowed up by the city's urban layout) built a defensive tower to look out for possible attacks. During the XV century the tower became a farmhouse, and in 1711 AD the property was acquired by the Cortada family that gave its name to the present venue.

# Friday - November 7, 2014

# Guided tour "Barrio Gótico

Meeting point: main lobby at 9:30 am. By bus. Return 3:30 pm.



A stroll through Barcelona's Gothic Quarter (Barrio Gótico) reveals to light the early Roman city of Barcino and the medieval town with its palazzos, mansions and Gothic churches. In fact, the original centre of Roman and medieval Barcelona still forms the core of 21st-century Barcelona. The Plaça del Rei proudly

showcases an architectural ensemble comprising the royal residences of the Catalan-Aragonese monarchs. Beneath it lie the impressive archaeological remains of Roman Barcino. Our tour will include a visit of the Cathedral: built over six centuries (13th-19th), this predominantly Gothic building reflects the different generations who have left their imprint, and the blend of architectural styles. We will also visit the Picasso Museum: housed in five Catalan-Gothic-style palazzos, it shows the solid bond between the Malaga-born genius and the city of Barcelona. The permanent collection comprises over 3,800 works from different periods, but with particular emphasis on works from his formative years and youth.

# Closing Dinner - Museu Marítim

Meeting point: main lobby at 7:30 pm. Transfer by bus. Av. de les Drassanes, s/n - tel. +34 93 3429920



The Museu Marítim is located by the waterfront, in one of Barcelona's finest landmark buildings: the Reials Drassanes, the medieval shipyards which are a unique example of civic Gothic architecture. The high point of the Museum's permanent collection is the *Real* - a full-scale replica of the galley

used by Don Juan of Austria at the battle of Lepanto in 1571 AD, which is housed in the *Grada Mayor* where our aperitif will be served. The Forum closing dinner will then take place in the recently restored Sala Marques des Comillas, a 300-year-old hall, and the most spectacular space in the Reials Drassanes.

# Saturday - November 8, 2014

# **OPTIONAL EXCURSIONS**

Two optional full-day excursions are offered for Saturday, November 8, one in the city: "Montjuïc and Miró's Foundation", which is suitable for those who will need to leave Barcelona in the afternoon, and the other one to Sant Sadurni d'Anoia: "Cavas Codorníu tour". The Saturday excursions will afford the delegates and their guests a further excellent opportunity for networking or just relaxed socialising with other delegates and old friends to discuss matters of mutual interest. Both tours include lunch.

# Option A: Barcelona "Montjuïc and Miró's Foundation"

Meeting point: main lobby at 9:30 am. By bus.



"Understanding urbanism from the top of the city": the hill of Montjuïc has borne witness to, and been the focus of, key events that have shaped its personality. The first was the 1929 International Exhibition held in Barcelona, which fostered the develop-

ment of the zone. More recently, the 1992 Olympic Games brought about major renewal.

We will start by introducing the history of Barcelona from Montjuïc, where we can enjoy a panoramic view of the whole city. From there, we will understand how Barcelona has been built and how it has been planned down through the centuries. Our programme will also include a visit of the Joan Miró Foundation: located in Montjuïc park, in a building designed by Josep Lluís Sert, the museum houses the most important public collection of works by the famous Catalan surrealist artist, Joan Miró.

# Option B: Sant Sadurni d'Anoia "Cavas Codorníu tour"

Meeting point: main lobby at 9:30 am. By bus.



A privileged geographical location on a plateau near the sea, protected by mountains, the mild climate of the Mediterranean coast and the permeable soil have all made the Alt Penedès region the leading wine and cava producer of Catalonia.

Its wineries are renowned for their innovative and pioneering approach. The town of *Sant Sadurni d'Anoia* began producing the local sparkling wine, known as cava, in 1872 and, since then, the cava-producing sector has become the most successful in the Catalan wine industry.

We will enjoy an exclusive guided tour of the *Cavas Codorniu* winery, including a cava tasting. We will admire the splendid architecture by the modernist architect Josep Puig, declared historic artistic monument in 1976, while learning about the cava process during a train tour through the old cellars.
